Terms and Conditions

The term of this Rental Agreement ("Agreement") is a minimum of 24 months from the date of Aetrex's acceptance ("Initial Term"), and month-to-month thereafter. Rental payments shall be due within thirty (30) calendar days from receipt of Aetrex's invoice. If Renter terminates prior to expiration of the Initial Term, Renter shall be responsible for payments of the entire Initial Term. After the Initial Term, Renter may return the equipment and cancel this Agreement. However, this Agreement will remain in effect until Aetrex receives the returned equipment. Freight charges to Aetrex are Renter's responsibility. The equipment must be maintained and returned in good working order, except ordinary wear and tear. Renter is responsible for all costs of repair or replacement caused by damage during Renter's possession, custody, or control. If any equipment is damaged beyond repair, is lost or stolen, or if Renter fails to return equipment when due, Renter shall reimburse Aetrex for the full replacement value. Renter shall, during the entire term of this Agreement and at its expense, keep the equipment insured with a reputable carrier, in an amount equaling the equipment value, against fire, theft, and loss, and name Aetrex as an additional insured and loss payee. Payment of any kind overdue by seven (7) calendar days shall entitle Aetrex to automatically charge and be paid by Renter's credit card listed below for such amounts. This Agreement is the entire agreement between the parties and supersedes all prior understandings and agreements. All ownership rights, title, and interest in and to all equipment placed and displayed hereunder shall remain with Aetrex at all times. All sums are in U.S. currency. This Agreement shall be governed and construed in English and under New Jersey law without regard to conflicts of laws principles. Any dispute arising hereunder shall be filed and resolved exclusively in the appropriate State or Federal Court in the State of New Jersey.

* Renter is responsible for all applicable taxes.
